**EXEMPTIONS MAY INCLUDE:**

1. Non-profit corporations and associations organized for religious, charitable, or educational purposes.
2. Service trades such as barbers, laundries, and cleaning and dyeing establishments, except to the extent that a part of their business may consist of the sale of goods, wares, and merchandise.
3. Receipts from shipment of goods moving in Interstate Commerce.
4. Any person vending or disposing of articles of his own growth, produce, or manufacture.
5. Beer Distributor (BEER ONLY.)

**EXCLUSIONS MAY INCLUDE:**

1. Sales returns and allowances for damaged or defective goods, provided such items have been included in gross sales.
2. Trade discounts, *i.e.* discounts deducted from the face of the bill as a medium of adjusting the list price.
3. Federal and State Excise taxes may be excluded from the gross volume of business, provided such taxes are separately stated on the evidence of charge or sale.
  - a) Federal Tax on admissions and dues.
  - b) Federal Retailers Excise Tax on jewelry, furs, and fur articles, toilet preparations, and luggage.
  - c) Pennsylvania Liquid Fuels Tax (Gasoline Only).
  - d) Pennsylvania Sales Tax (Retail Only).

Legal Tax Service, Inc. is authorized by law to examine the books, papers, and records of any taxpayer, to verify the accuracy of all tax forms and to ascertain the tax due. Therefore, every taxpayer is directed and required by law to give Legal Tax Service, Inc. the means, facilities, and opportunity for such examination and investigation.

**Please note that in addition to the quarterly forms, we require that a FINAL form be filed with by April 15 every year.**

We also ask that you please call us prior to, or shortly after, your business closes so that we may get your accounts squared away.
